

## PRIVACY POLICY WWW.TICKET.ENERGYLANDIA.PL/PRODUCT

### 1. General.

1. The operator of [website address, <http://ticket.energylandia.pl/product> Website is: ENERGY 2000 TECHNICO M A GOCZAŁ SPÓŁKA JAWNA (KRS [company registration number]: 0000185624, NIP [tax identification number]: 5511735768, REGON [company identification number]: 070883960)
2. The Website performs the functions of obtaining information about users and their behavior in the following way:
  - a. By information entered voluntarily in forms
  - b. By saving cookies in the terminal devices.
  - c. By collecting web server logs by the hosting operator, operating at [www.energylandia.pl](http://www.energylandia.pl) address.

### 2. Information in forms.

1. The Website collects information provided voluntarily by the user.
2. The Website can also save information about the connection parameters (time stamp, IP address)
3. The data in the form is not made available to third parties otherwise than with the consent of the user.
4. The data provided in the form may be a set of potential customers, registered by the Website Operator in a register kept by the Inspector General for Personal Data Protection.
5. The data provided in the form is processed for the purpose resulting from the function of a specific form, e.g. in order to perform the process of the service request or business contact handling.
6. The data provided in the forms may be provided to entities technically performing certain services - in particular, it concerns the transfer of information about the registered domain holder to entities being the Internet domain operators (primarily NASK *Naukowa i Akademicka Sieć Komputerowa* ("Research and Academic Computer Network"), payment services or other entities, with whom the Website Operator cooperates in this respect.

### 3. Information about cookies.

1. The Website uses cookies.
2. Cookie files are IT data, in particular text files, which are stored in the Website User's end device and are intended for using the Website's pages. Cookies usually contain the name of the website from which they originate, their storage time on the end device and a unique number.
3. The entity that places cookies on the Website User's end device and who has access to them is the Website operator.
4. Cookies are used for the following purposes:
  - a. creating statistics that help to understand how the Website Users use websites, which allows improving their structure and content;
  - b. maintaining the Website User's session (after logging in), thanks to which the User does not have to re-enter his/her login and password on every subpage of the Website;
  - c. defining a user's profile in order to display him /her tailored materials in advertising networks, in particular the Google network.
5. The Website uses two basic types of cookies: session cookies and persistent cookies. Session cookies are temporary files that are stored on the User's end device until logging out, leaving the website or turning off the software (web browser). Persistent cookies are stored on the User's device for the time specified in the cookie file parameters or until they are deleted by the User.

6. Software for browsing websites (web browser) usually by default allows storing cookies on the User's end device. The Website Users can change the settings in this respect. The web browser allows to delete cookies. It is also possible to automatically block cookies. Detailed information on this subject is provided in the help service or documentation of the web browser.
7. Limitations of the use of cookies may affect some of the functionalities available on the Website.
8. Cookies placed on the Website User's end device may also be used by advertisers and partners cooperating with the Website operator.
9. We recommend reading the privacy policies of those companies in order to learn the rules of using cookies used in the statistics: Google Analytics privacy policy
10. Cookies may be used by advertising networks, in particular the Google network, to display advertisements tailored to the manner in which the user uses the Website. For this purpose, they can save information about the user's navigation path or the time of staying on a given website.
11. In terms of information about user preferences collected by the Google advertising network, the user can view and edit information derived from cookies using the following tool: <https://www.google.com/ads/preferences/>

#### 4. Server logs.

1. Information about some of the behaviors of users are subject to logging in the server layer. That data are used only to manage the website and to ensure the most efficient service of hosting services.
2. The browsed resources are identified by URL addresses. In addition, the following may be saved:
  - a. time of the inquiry receipt,
  - b. time of the response sending,
  - c. name of the client's station - the identification executed by HTTP protocol,
  - d. information about errors that occurred during the execution of the HTTP transaction,
  - e. URL address of the website previously visited by the user (referrer link) - in the case when the transition to the Website was performed via a link,
  - f. information about the user's browser,
  - g. Information about the IP address.
3. The above data is not associated with specific people browsing the website
4. The above data is used only for server administration purposes.

#### 5. Providing data.

1. Data is made available to third parties only within legally permitted limits.
2. Data enabling the identification of a natural person is made available only with the consent of that person.
3. The operator may be required to provide information collected by the Website to authorized authorities on the basis of lawful requests to the extent resulting from the request.

#### 6. Managing cookie files - how to provide and withdraw the consent in practice?

1. If the user does not want to receive cookies, he/she can change the browser settings. We reserve that disabling the cookies necessary for authentication processes, security, maintaining user preferences can make it difficult, and in extreme cases may prevent the use of websites
