- 3. Terms and Conditions these Terms and Conditions of the Promotion.

- 5. Promotional tickets may be purchased to 28.02.2025. The promoter reserves the right to change the term of the promotion.

- **8.** Promotional electronic and gift tickets are available at prices:
 - 1. Standard yearly ticket over 140 cm 799 PLN/pc.
 - 2. Discounted yearly ticket up to 140 cm 649 PLN/pc.
- **9.** To claim a Energy Pass for free, you must add a promotional ticket (electronic or gift) to your cart. The promotion accrues in the shopping cart.
- 10. Tickets purchased during the promotion can be exchanged for yearly card until 26.10.2025 according to the expiration date indicated on the ticket on the days and hours according to the Park's opening calendar available on the website: https://energylandia.pl/en/plan-your-stay/calendar/. - **13.** A maximum of 10 tickets can be purchased in the promotion.
- **14.** Promotional tickets cannot be resold or exchanged for another type or kind of ticket. Promotional tickets cannot be surcharged for this purpose.
