



Terms and conditions of the promotion "SECOND ANNUAL TICKET -50%".

§1 GENERAL PROVISIONS

1. The organiser of the promotion in the form of discounted ticket sale to the Energylandia Theme Park, hereinafter referred to as the "Promotion" is ENERGYLANDIA GOCZAŁ FAMILY SP. K. with registered offices in Zator (32-640 Zator) at al. 3 Maja 2, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the "Organisers".
2. Participant – an individual who has met the conditions specified in §2 of these Terms and Conditions.
3. Terms and Conditions – these Terms and Conditions of the Promotion.
4. Promotion – this promotion, organised under the name of "**SECOND ANNUAL TICKET -50%**".
5. Promotional tickets may be purchased **to 26.01.2026. The promoter reserves the right to change the term of the promotion.**

7. The promotional discounts apply to electronic and gift annual tickets (standard annual ticket from 140 cm, discounted annual ticket up to 140 cm) purchased only via our website - in tab: <https://ticket.energylandia.pl/en/products/promotion/2-529>
8. Promotional electronic and gift tickets are available at prices:
 1. Standard annual ticket over 140 cm – 899 PLN/pc.
 2. Discounted annual ticket up to 140 cm – 749 PLN/pc.
9. To claim second annual ticket with a -50% discount, you must add two yearly ticket of specific type (two electronic or two gift) to your cart. The promotion accrues in the shopping cart.
10. Tickets purchased during the promotion can be exchanged for an annual card from **until 31.10.2026** according to the expiration date indicated on the ticket on the days and hours according to the Park's opening calendar available on the website: <https://energylandia.pl/en/plan-your-stay/calendar/>. The Energylandia Theme Park reserves the right to change the Park's opening calendar.
11. Promotional tickets in electronic form shall be sent to an email address indicated in the order, in the PDF form. Gift tickets included in the promotion purchased via the website will be sent to the Participant's address specified in the order.
12. Promotions cannot be combined.
13. A maximum of 10 tickets can be purchased in the promotion.



- 14.** Promotional tickets cannot be resold or exchanged for another type or kind of ticket. Promotional tickets cannot be surcharged for this purpose.
- 15.** Promotional tickets offered under this promotion cannot be purchased through an installment payment plan. The purchase of promotional tickets is only possible through a one-time payment of the full amount due for the ticket.

§2 CONDITIONS OF PARTICIPATION IN THE PROMOTION

- 1.** This Promotion is intended exclusively for individuals (consumers within the meaning of Article 22 of the Civil Code) present on the territory of the Republic of Poland, who at the date of joining the Promotion are at least 18 years old and meet the other provisions and conditions of these Terms and Conditions.
- 2.** By joining the Promotion, the Participants acknowledge that they have familiarised themselves with the content of the Terms and Conditions, and that they undertake to observe the rules specified in the Terms and Conditions, as well as confirm that they meet the conditions which entitle them to participate in the Promotion.

§3 FINAL PROVISIONS

- 2.** The Organisers reserve the right to amend these Terms and Conditions at any time, with no reason given. Such amendments, however, shall not infringe on the rights acquired by the Participants.
