

Conditions of the "YEARLY TICKETS 3+1 FREE" promotion

§1 GENERAL PROVISIONS

- The organiser of the promotion in the form of discounted ticket sale to the Energylandia Theme Park, hereinafter referred to as the "Promotion" is ENERGYLANDIA GOCZAŁ FAMILY SP. K. with registered offices in Zator (32-640 Zator) at al. 3 Maja 2, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the "Organisers".
- 2. Participant an individual who has met the conditions specified in §2 of these Terms and Conditions.
- 3. Terms and Conditions these Terms and Conditions of the Promotion.
- 4. Promotion this promotion, organised under the name of "YEARLY TICKETS 3+1 FREE".
- 5. Promotional tickets may be purchased to 08.11.2024.

- 7. The promotional discounts apply to electronic and gift yearly tickets Standard from 140 cm of height and Discounted yearly tickets up to 140 cm of height purchased only via our website in PROMOTION tab: https://ticket.energylandia.pl/en/products/promotion/2-529
- 8. Promotional tickets in an electronic form are available for purchase at the following prices:
 - 1. Standard yearly ticket over 140 cm 799 PLN/pc.
 - 2. Discounted yearly ticket up to 140 cm 649 PLN/pc.
- 9. Promotional tickets in a gift form are available for purchase at the following prices:
 - 1. Standard yearly ticket over 140 cm 799 PLN/pc.
 - 2. Discounted yearly ticket up to 140 cm 649 PLN/pc.
- **10.** To receive the fourth ticket **free of charge**, add the selected 4 promotional tickets to the shopping cart. The promotion accrues on the cheapest ticket in the cart. If you add 4 identical tickets to your cart, the promotion accrues on one of them.
- **11.** To qualify for the promotion, you must select four tickets in a specific form electronic or gift. If you mix tickets in different forms, the promotion will not apply.





- 12. Promotional electronic yearly tickets purchased through the PROMOTION tab will be delivered in electronic form of electronic coupons on the e-mail address. Promotional yearly tickets should be exchanged for a year-round ticket by 26.10.2025 at the individual ticket office of the Park.
- **13. Promotional gift yearly tickets** purchased through the PROMOTION tab will be delivered in gift form of coupons to the address. Promotional yearly tickets should be exchanged for a year-round ticket by **26.10.2025** at the individual ticket office of the Park.
- 14. The yearly ticket is valid for 365 days from the date of exchange of the coupon and may be used on days and at times in accordance with the Park's Calendar available at:<u>https://energylandia.pl/en/plan-your-stay/calendar/</u>
- **15.** Promotions cannot be combined.
- **16.** A maximum of 10 tickets can be purchased in the promotion.
- **17.** Promotional tickets cannot be resold or exchanged for another type or kind of ticket. Promotional tickets cannot be surcharged for this purpose.
- **18.** Promotional tickets offered under this promotion cannot be purchased through an installment payment plan. The purchase of promotional tickets is only possible through a one-time payment of the full amount due for the ticket.

§2 CONDITIONS OF PARTICIPATION IN THE PROMOTION

- 1. This Promotion is intended exclusively for individuals (consumers within the meaning of Article 22 of the Civil Code) present on the territory of the Republic of Poland, who at the date of joining the. Promotion are at least 18 years old and meet the other provisions and conditions of these Terms and Conditions.

By joining the Promotion, the Participants acknowledge that they have familiarised themselves with the content of the Terms and Conditions, and that they undertake to observe the rules specified in the Terms and Conditions, as well as confirm that they meet the conditions which entitle them to participate in the Promotion.
