



Terms and Conditions of the “HALLOWEEN NIGHT” promotion

§1 GENERAL PROVISIONS

1. The organiser of the promotion in the form of discounted ticket sale to the Energylandia Amusement Park, hereinafter referred to as the “Promotion” is ENERGY 2000 SP. Z O.O. ENERGYLANDIA SP.K. with registered offices in Przytkowice (34-141 Przytkowice) at ul. Przytkowice 532 A, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the “Organisers”.
2. Participant – an individual who has met the conditions specified in §2 of these Terms and Conditions.
3. Terms and Conditions – these Terms and Conditions of the Promotion.
4. Promotion – this promotion, organised under the name of “HALLOWEEN NIGHT”.
5. The aim of the Promotion is promoting an active way of spending leisure time.
6. Time of duration of the Promotion for the purchase of tickets at a discount is **from 21.09.2021 to 23.10.2021**, but these dates do not apply to the time when the ticket should be used, which is described later in the Regulations.
7. Discounted tickets may be purchased:
 - **from 21.09.2021 to 23.10.2021**, via the Energylandia Amusement Park’s website exclusively – in the HALLOWEEN NIGHT tab: <https://ticket.energylandia.pl/en/promotionpromo> in accordance with the regulations of online ticket sales to the Energylandia Amusement Park, taking into account this Regulations.
 - **on 23 October 2021** at the ticket offices of the Energylandia Amusement Park, Aleja 3 Maja 2, 32-640 Zator, during our opening hours.
8. The promotional discounts apply to electronic tickets (standard tickets 140 cm and up, discounted tickets up to 140 cm/ senior over 65 years of age) purchased only via our website – in the HALLOWEEN NIGHT tab: <https://ticket.energylandia.pl/en/promotionpromo> and at the ticket offices of the Energylandia Amusement Park on 23.10.2021. The promotion does not apply to gift tickets.
9. Promotional electronic tickets - purchased through the PROMOTION tab and delivered in electronic form - may be used only on 23 October 2021 in accordance with the Park’s Calendar available at: <https://energylandia.pl/en/plan-your-stay/calendar/>
10. The purchase of a promotional ticket is subject to wearing a full Halloween costume. A partial costume, such as a mask, or a cape, shall not be basis for promotion eligibility. The costume cannot be hidden under e.g. a coat or jacket which are not a part of it.
11. All Guests in full Halloween costumes are eligible for this promotion. To avoid any misunderstandings – the costumes are checked at the entrance. Our staff reserve the right to refuse the sale of a promotional ticket or to allow entry upon unsuccessful costume verification, which may result in the need to purchase tickets at full price, in accordance with the current pricelist.
12. This Promotion does not apply to any of the above-mentioned tickets purchased from any of the Partners of the Energylandia Amusement Park.
13. Promotional tickets are available for purchase at the following prices:
 - standard tickets 140 cm and up – 74,00 PLN /pc.
 - discounted tickets up to 140 cm/ senior over 65 years of age – 49 PLN /pc.
14. One promotional ticket per Guest (in full costume).



15. Promotion only available to Guests in full Halloween costumes who purchased their tickets on our website (tab HALLOWEEN NIGHT): <https://ticket.energylandia.pl/pl/promotionpromo> or at the Park's ticket offices on the day of the promotion (23 October 2021).
16. Promotional ticket in electronic form purchased via the website referred to in point 7 above, will be sent to the email address provided in the order in PDF format.
17. The promotional ticket in electronic form shall be presented in the paper form or in electronic form, eg on a smartphone or other device enabling it to be read. The Organizer reserves that it shall not be liable in the event of the inability to read the ticket in electronic form for reasons not attributable to the Organizer.
18. One person/company may purchase up to 10 tickets in all orders.
19. Promotional tickets are not subject to further resale, and may not be exchanged for another type of ticket.
20. In accordance with the Bylaws of the online ticket sales to the Energylandia Amusement Park, the Seller hereby informs that in the event of ordering an electronic ticket, entitling the holder to enter the Amusement Park, at the specified time listed on the ticket, the Customer's right to withdraw from the contract concluded in this manner, in compliance with Article 38 pt 12 of the Act of 30 May 2014 on Consumer Rights, has been voided.
21. If the Energylandia Amusement Park is closed before October 31, 2021 because of COVID-19, due to the introduction by the Polish legislator of a ban on the operation of amusement parks, the validity of promotional tickets are automatically extended until June 24, 2022. Attention is drawn to the point 20 above. The organiser reminds that in October 2021 the Energylandia Amusement Park, according to its opening calendar, will be closed on Mondays, Tuesdays and Wednesdays.
22. Discounted tickets (one-day at 49 PLN) apply only to children up to 140 cm in height and seniors over 65 years of age.
23. The promotional tickets entitle the holders to use all attractions, as well as the Water Park Zone, with no limitations and in compliance with the policies. For the safety of the Guests using this zone, the Water Park is made available only in favourable weather and meteorological conditions, i.e. air temperature above 20 degrees Celsius, and therefore only during the hours allowing the use of this zone during the opening hours of the Amusement Park.
24. This Promotion has been organised on the territory of the Republic of Poland, and the participation in it is voluntary.
25. Promotions cannot be combined.

§2 CONDITIONS OF PARTICIPATION IN THE PROMOTION

1. This Promotion is intended exclusively for individuals (consumers within the meaning of Article 22 of the Civil Code) present on the territory of the Republic of Poland, who at the date of joining the. Promotion are at least 18 years old and meet the other provisions and conditions of these Terms and Conditions.
2. By joining the Promotion, the Participants acknowledge that they have familiarised themselves with the content of the Terms and Conditions, and that they undertake to observe the rules specified in the Terms and Conditions, as well as confirm that they meet the conditions which entitle them to participate in the Promotion.
3. In order to participate in the Promotion one needs to purchase a ticket via the designated website listed above.

§5 FINAL PROVISIONS

1. These Regulations are available at energylandia.pl and www.ticket.energylandia.pl. The regulations for the online sale of tickets to the Energylandia Amusement Park define the conditions for the sale of tickets and other information provided for by law, including the terms of complaints - and each of the Promotion Participant is obliged to read them during placing the order via the websites referred to in §1 point 8 above.
2. The Organisers reserve the right to amend these Terms and Conditions at any time, with no reason given. Such amendments, however, shall not infringe on the rights acquired by the Participants.
