

Conditions of the "FIRST MINUTE PROMOTION REGISTER YOUR SCHOOL TO 31.03.2024 AND RECEIVE 200 PLN DISCOUNT".

§1 GENERAL PROVISIONS

- 1 The organiser of the promotion in the form of discounted ticket sale to the Energylandia Theme Park, hereinafter referred to as the "Promotion" is ENERGYLANDIA GOCZAŁ FAMILY SP. K. with registered offices in Zator (32-640 Zator) at al. 3 Maja 2, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the "Organisers".
- 2 Participant an individual who has met the conditions specified in §2 of these Terms and Conditions.
- 3 Terms and Conditions these Terms and Conditions of the Promotion.
- 4 Promotion this promotion organised under the name "FIRST MINUTE PROMOTION REGISTER YOUR SCHOOL TO 31.03.2024 AND RECEIVE 200 PLN DISCOUNT".
- 5. The aim of the Promotion is to encourage people to spend time actively.
- **6.** The duration of the Promotion to obtain a discount includes the period of making a booking for a school trip until 31.03.2024 realised in the summer season i.e. from 6.04 to 27.10.2024.
- 7. The promotion is only valid for school trips booked by 31 March 2024.
- 8 The discount can be used when finalising a reservation at the group box offices of the Energylandia, during the hours and days of their operation in accordance with the opening calendar of the Energylandia, which is available at www.energylandia.pl.
- 9. The discount applies to the accrual of a 200 PLN discount on the total amount shown on the receipt when finalising your booking at the Park's group box offices.
- 10. The discount can be used when finalising a reservation made by 31.03.2024 at the Park's group box offices on days and times according to the Park's opening calendar found on the website: https://energylandia.pl/en/plan-your-stay/calendar/ and with the generally applicable school offer rules. The promotion does not apply when purchasing tickets from authorised partners of the Energylandia.
- 11. The discount can only be calculated after an advance reservation made by 31.03.2024.
- 12. The date of booking, not the date of arrival, determines the promotion.
- 13. Group tickets are only for organised groups of at least 15 children.
- **14.** The promotion is valid up to and including 31.03.2024.
- 15. The discount obtained is only subject to finalisation on the day of arrival.
- 16. The discount cannot be received at any time other than in accordance with the terms and conditions of the Promotion.
- 17. The -200 PLN discount cannot be used individually.
- 18. The Promotion is organised on the territory of the Republic of Poland and participation is voluntary.
- 19. The promotion does not combine with other promotions and discounts.



- **20.** A discount of PLN -200 will be charged once for a group that arrives by one coach. An additional discount will be given to the group if they arrive by a second coach and this is confirmed by the registration number.
- 21. The organiser reserves the right to change the conditions for discounts without prior notice.

§2 TERMS OF PARTICIPATION IN THE PROMOTION

- 1. The promotion is intended only for students of school trips located in the territory of Poland, which meet the other provisions and conditions of the Regulations.
- 2. Joining the Promotion by the Participant means that he has read the Regulations, that he undertakes to comply with the rules set out in the Regulations, and confirms that he meets the conditions that entitle him to participate in the Promotion.
- **3.** In order to participate in the promotion, it is necessary to book the arrival of a school group at least one day in advance and meet the conditions set out in the Promotion.

§3 PERSONAL DATA

(applies to tickets purchased at the group ticket offices of the Energylandia Amusement Park)

- 1. The administrator of personal data provided by the Participants is the Organizer.
- 2. Providing personal data by Participants is voluntary.
- **3.** Participants' personal data will be used only for operational purposes related to the Promotion. The Participant has the right to inspect their data.
- 4. The Organizer does not sell or share the personal data of the Promotion Participants with other entities.

§4 COMPLAINT PROCEDURE

- 1. Any complaints regarding the way of conducting the Promotion should be reported by the Participants in writing to the secretariat located in the Energylandia Amusement Park in Zator, Aleja 3 Maja 2, 32-640 Zator.
- 2. A written complaint should contain the name, surname and exact address of the Participant, a photocopy of the ticket and a detailed description and justification of the complaint.
- 3. Complaints will be considered by the Organizer within 30 days from the date of their receipt.
- **4.** The Participant will be notified of the method of considering the complaint by registered letter to the address provided in the complaint, sent within 30 days from the date of consideration of the given complaint.
- 5. Claims not considered or not included in the complaint procedure may be pursued before a common court.
- 6. In the case of tickets purchased from intermediaries, distributors, tourist offices, etc., complaints and possible reservations and complaints should be addressed directly to the entity from which the tickets were purchased. Complaints and complaints regarding such tickets will not be considered by Energylandia.



§5 FINAL PROVISIONS

- 1. These Regulations are available at the secretariat located in the Energylandia Amusement Park and on the website https://energylandia.pl/en/ as well as from the Partners of the Energylandia Amusement Park.
- 2. The Organizer reserves the right to make changes to these Regulations at any time without giving any reason. However, changes to the regulations may not infringe the rights acquired by the Participant.
