



Conditions of the “GIFT TICKETS + FREE MASCOT”

§1 GENERAL PROVISIONS

1. The organiser of the promotion in the form of discounted ticket sale to the Energylandia Theme Park, hereinafter referred to as the “Promotion” is ENERGYLANDIA GOCZAŁ FAMILY SP. K. with registered offices in Zator (32-640 Zator) at al. 3 Maja 2, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the “Organisers”.
2. Participant – an individual who has met the conditions specified in §2 of these Terms and Conditions.
3. Terms and Conditions – these Terms and Conditions of the Promotion.
4. Promotion – this promotion, organised under the name of “GIFT TICKETS + FREE MASCOT”.
5. The aim of the Promotion is promoting an active way of spending leisure time.
6. Time of duration of the Promotion for the purchase of tickets at a discount is **from 29.11.2024 to 05.12.2024**, but these dates do not apply to the time when the ticket should be used, which is described later in the Regulations.
7. Promotional tickets may be purchased: from 29.11.2024 to 05.12.2024, via the Energylandia Theme Park’s website exclusively – in the GIFT tab:

The promotional discounts apply to gift tickets (Standard gift ticket from 140 cm, Discounted gift ticket up to 140 cm / seniors over 65 years of age, 2-DAY STANDARD GIFT PASS from 140 cm, 2-DAY DISCOUNTED GIFT PASS up to 140 cm / seniors over 65 years of age, 3-DAY STANDARD GIFT PASS from 140 cm, -DAY DISCOUNTED GIFT PASS up to 140 cm / seniors over 65 years of age) purchased only via our website – in the GIFT tab:

9. **Promotional tickets are available for purchase at the following prices:**
 - Standard gift ticket from 140 cm in height - 199pln/pc.
 - Discounted gift ticket up to 140 cm in height / seniors over 65 years of age - 159pln/pc.
 - 2-day standard gift pass from 140 cm in height - 359pln/pc.
 - 2-day discounted gift pass up to 140 cm in height / seniors over 65 years of age - 289pln/pc.
 - 3-day standard gift pass from 140 cm in height - 499pln/pc.
 - 3-day discounted gift pass up to 140 cm in height / seniors over 65 years of age - 399pln/pc.
10. To take advantage of the promotion, add the selected mascot to the shopping cart. The regular price of the mascot will be automatically discounted to PLN 0 if there are at least 2 promotional tickets in the cart. The participant of the promotion is required to select the type of mascot - Emi or Enerigus - when adding products to the cart.

12. This Promotion does not apply to any of the above-mentioned tickets purchased at the ticket offices of the Energylandia Theme Park, or from any of the Partners of the Energylandia Theme Park.
13. One person/company may purchase up to 10 tickets in all orders.
14. Promotional tickets are not subject to further resale, and may not be exchanged for another type of ticket.
15. In accordance with the regulations of the online sale of tickets to the Energylandia Amusement Park and the provisions of the Act dated 30th May 2014 on consumer rights, the Seller hereby informs that in the event of ordering an electronic ticket, entitling the holder to enter the Amusement Park, at the specified time listed on the ticket, the Customer's right to withdraw from the contract concluded in this manner, in compliance with Article 38 pt 12 of the Act of 30 May 2014 on Consumer Rights, has been voided.
16. Discounted ticket apply only to children up to 140 cm in height and seniors over 65 years old..
17. The promotional tickets entitle the holders to use all attractions with no limitations and in compliance with the policies.
18. This Promotion has been organised on the territory of the Republic of Poland, and the participation in it is voluntary.
19. Promotions cannot be combined.

§2 CONDITIONS OF PARTICIPATION IN THE PROMOTION

1. This Promotion is intended exclusively for individuals (consumers within the meaning of Article 22 of the Civil Code) present on the territory of the Republic of Poland, who at the date of joining the. Promotion are at least 18 years old and meet the other provisions and conditions of these Terms and Conditions.
2. By joining the Promotion, the Participants acknowledge that they have familiarised themselves with the content of the Terms and Conditions, and that they undertake to observe the rules specified in the Terms and Conditions, as well as confirm that they meet the conditions which entitle them to participate in the Promotion.
3. In order to participate in the Promotion one needs to purchase a ticket via the designated website listed above.



§3 FINAL PROVISIONS

2. The Organisers reserve the right to amend these Terms and Conditions at any time, with no reason given. Such amendments, however, shall not infringe on the rights acquired by the Participants.
