



Terms and conditions of the promotion "HOLIDAYS 2026 + WINTER - 1+1 FREE!"

§1 GENERAL PROVISIONS

1. The organiser of the promotion in the form of discounted ticket sale to the Energylandia Theme Park, hereinafter referred to as the "Promotion" is ENERGYLANDIA GOCZAŁ FAMILY SP. K. with registered offices in Zator (32-640 Zator) at al. 3 Maja 2, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the "Organisers".
2. Participant – an individual who has met the conditions specified in §2 of these Terms and Conditions.
3. Terms and Conditions – these Terms and Conditions of the Promotion.
4. Promotion – this promotion, organised under the name of "HOLIDAYS 2026 + WINTER - 1+1 FREE!"
5. Promotional tickets may be purchased to **07.12.2025**.
6. Promotional tickets may be purchased via the Energylandia Theme Park's website exclusively – in the PROMOTION tab:

7. The promotional discounts apply to electronic 1-day, 2-day and 3-day passes for high season (Standard 1-day/2-day/3-day pass from 140 cm, Discounted 1-day/2-day/3-day pass up to 140 cm / senior from 65 years of age) purchased only via our website - in PROMOTION tab: <https://ticket.energylandia.pl/en/products/promotion/2-529>
8. Promotional tickets in an electronic form are available for purchase at the following prices:
 1. **Standard ticket over 140 cm – 219 PLN/pc.**
 2. **Discounted ticket up to 140 cm / senior over 65 years of age – 179 PLN/pc.**
 3. **Standard 2-day pass over 140 cm – 399 PLN/pc.**
 4. **Discounted 2-day pass up to 140 cm / senior over 65 years of age – 329 PLN/pc**
 5. **Standard 3-day pass over 140 cm – 559 PLN/pc.**
 6. **Discounted 3-day pass up to 140 cm / senior over 65 years of age – 459 PLN/pc**
9. To receive Winter Kingdom **free** ticket, add a minimum of 2 tickets (1 for high season tickets, 1 for Winter Kingdom). The promotion accrues in the shopping cart. Free tickets are one-day tickets of the same type as paid tickets (i.e., normal from 140 cm or discounted up to 140 cm/seniors over 65).



10. Tickets for high season purchased during the promotion can be used until 31.10.2026 according to the expiration date indicated on the ticket on the days and hours according to the Park's opening calendar available on the website: <https://energylandia.pl/en/plan-your-stay/calendar/>. On the other hand, tickets for the Winter Kingdom season can be used until 08.02.2026 according to the expiration date indicated on the ticket on the days and hours according to the Park's opening calendar. The Energylandia Theme Park reserves the right to change the Park's opening calendar.
11. Promotional tickets in electronic form shall be sent to an email address indicated in the order, in the PDF form.
12. Promotions cannot be combined.
13. A maximum of 10 tickets can be purchased in the promotion.
14. Promotional tickets cannot be resold or exchanged for another type or kind of ticket. Promotional tickets cannot be surcharged for this purpose.
15. Promotional tickets offered under this promotion cannot be purchased through an installment payment plan. The purchase of promotional tickets is only possible through a one-time payment of the full amount due for the ticket.

§2 CONDITIONS OF PARTICIPATION IN THE PROMOTION

1. This Promotion is intended exclusively for individuals (consumers within the meaning of Article 22 of the Civil Code) present on the territory of the Republic of Poland, who at the date of joining the Promotion are at least 18 years old and meet the other provisions and conditions of these Terms and Conditions.
2. By joining the Promotion, the Participants acknowledge that they have familiarised themselves with the content of the Terms and Conditions, and that they undertake to observe the rules specified in the Terms and Conditions, as well as confirm that they meet the conditions which entitle them to participate in the Promotion.
3. In order to participate in the Promotion one needs to purchase a ticket via the designated website listed above.



§3 FINAL PROVISIONS

The regulations for the online sale of tickets to the Energylandia Theme Park define the conditions for the sale of tickets and other information provided for by law, including the terms of complaints - and each of the Promotion Participant is obliged to read them during placing the order via the websites referred to in §1 point 8 above.
2. The Organisers reserve the right to amend these Terms and Conditions at any time, with no reason given. Such amendments, however, shall not infringe on the rights acquired by the Participants.
