



## Terms and conditions of the promotion "SECOND TICKET -50%".

### §1 GENERAL PROVISIONS

1. The organiser of the promotion in the form of discounted ticket sale to the Energylandia Theme Park, hereinafter referred to as the "Promotion" is ENERGYLANDIA GOCZAŁ FAMILY SP. K. with registered offices in Zator (32-640 Zator) at al. 3 Maja 2, with tax ID number NIP: 5511735768, and REGON: 070883960, hereinafter referred to as the "Organisers".
2. Participant – an individual who has met the conditions specified in §2 of these Terms and Conditions.
3. Terms and Conditions – these Terms and Conditions of the Promotion.
4. Promotion – this promotion, organised under the name of "**SECOND TICKET -50%**".
5. Promotional tickets may be purchased **to 15.02.2026. The promoter reserves the right to change the term of the promotion.**

The promotional discounts apply to electronic tickets for high and low season and gift tickets for high season (Standard 1-day/2-day/3-day pass from 140 cm, Discounted 1-day/2-day/3-day pass up to 140 cm / senior from 65 years of age) purchased only via our website - in PROMOTION tab: <https://ticket.energylandia.pl/en/products/promotion/2-529>
8. Promotional electronic and gift tickets are available at prices:

Gift and electronic tickets for high season:

1. Standard ticket over 140 cm – 219 PLN/pc.
2. Discounted ticket up to 140 cm / senior over 65 years of age – 179 PLN/pc.
3. Standard 2-day pass over 140 cm – 399 PLN/pc.
4. Discounted 2-day pass up to 140 cm / senior over 65 years of age – 329 PLN/pc
5. Standard 3-day pass over 140 cm – 559 PLN/pc.
6. Discounted 3-day pass up to 140 cm / senior over 65 years of age – 459 PLN/pc



Electronic tickets for low season:

- 1. Standard ticket over 140 cm – 199 PLN/pc.**
- 2. Discounted ticket up to 140 cm / senior over 65 years of age – 159 PLN/pc.**
- 3. Standard 2-day pass over 140 cm – 359 PLN/pc.**
- 4. Discounted 2-day pass up to 140 cm / senior over 65 years of age – 289 PLN/pc**
- 5. Standard 3-day pass over 140 cm – 509 PLN/pc.**
- 6. Discounted 3-day pass up to 140 cm / senior over 65 years of age – 409 PLN/pc**
- 9.** To claim a second ticket with a -50% discount, you must add a minimum of 2 promotional tickets of specific type (electronic/gift) to your cart. The promotion accrues in the shopping cart.
- 10.** Tickets for low season purchased during the promotion can be used from **29.11.2025 to 26.06.2026 and from 01.09.2026 to 31.10.2026**. Tickets for high season can be used from **29.11.2025 to 31.10.2026** according to the expiration date indicated on the ticket on the days and hours according to the Park's opening calendar available on the website: <https://energylandia.pl/en/plan-your-stay/calendar/>. The Energylandia Theme Park reserves the right to change the Park's opening calendar.
- 11.** Promotional tickets in electronic form shall be sent to an email address indicated in the order, in the PDF form.
- 12.** Promotions cannot be combined.
- 13.** A maximum of 10 tickets can be purchased in the promotion.
- 14.** Promotional tickets cannot be resold or exchanged for another type or kind of ticket. Promotional tickets cannot be surcharged for this purpose.
- 15.** Promotional tickets offered under this promotion cannot be purchased through an installment payment plan. The purchase of promotional tickets is only possible through a one-time payment of the full amount due for the ticket.

## §2 CONDITIONS OF PARTICIPATION IN THE PROMOTION

- 1.** This Promotion is intended exclusively for individuals (consumers within the meaning of Article 22 of the Civil Code) present on the territory of the Republic of Poland, who at the date of joining the Promotion are at least 18 years old and meet the other provisions and conditions of these Terms and Conditions.

By joining the Promotion, the Participants acknowledge that they have familiarised themselves with the content of the Terms and Conditions, and that they undertake to observe the rules specified in the Terms and Conditions, as well as confirm that they meet the conditions which entitle them to participate in the Promotion.
3. In order to participate in the Promotion one needs to purchase a ticket via the designated website listed above.
